#### Section 4 - First Aid Measures

#### Section 5 - Fire Fighting Measures

**Suitable extinguishing media:** For small (incipient) fires, use media such as "alcohol" foam, dry chemical, or carbon dioxide. For large fires, apply water from as far as possible. Use very large quantities (flooding) of water applied as a mist or spray; solid streams of water may be ineffective. Cool all affected containers with flooding quantities of water.

**Special protective equipment for fire-fighters:** Wear self contained apparatus breathing apparatus for fire fighting if necessary.

#### Section 6 - Accidental Release Measures

**Conditions for safe storage:** Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.  
Recommended storage temperature: 2 - 8 °C Stench.  
Handle and store under inert gas. Air and moisture sensitive.

<b>Respiratory protection:</b>	Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).
<b>Hand protection</b>	Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product.
