Section 4 – First Aid Measures

General advice:	Consult a physician. Show this safety data sheet to the doctor in attendance.

Section 5 – Fire Fighting Measures

Suitable extinguishing media:	For small (incipient) fires, use media such as “alcohol” foam, dry chemical or carbon dioxide. For large fires apply water form as far as possible. Use very large quantities (flooding) of water applied as a mist or spray; solid streams of water may be ineffective. Cool all after containers with flooding quantities of water.
Special protective equipment for fire-fighters:	Wear self contained apparatus breathing apparatus for fire fighting if necessary.

Section 6 – Accidental Release Measures

Personal precautions:	Avoid breathing vapors, mist or gas. Use personal protective equipment. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.
Environmental precautions:	Prevent further leakage or spillage if safe to do so. Do not let product enter drains.
Methods and materials for containment and cleaning up	Contain spillage and then collect with non-combustive absorbent material (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container and dispose of as hazardous waste. Keep in suitable, closed containers for disposal.

Precautions for safe handling:	Avoid contact with skin and eyes. Avoid inhalation or vapor or mist. Keep away from sources of ignition – No smoking. Take measures to prevent build up of electrostatic charge.
Conditions for safe storage:	Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Handle and open container with care.

Respiratory protection:	Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).
Hand protection	The selected protective gloves have to satisfy the specifications of EU Directive 89/686/EEC and the standard EN 374 derived from it. Handle with gloves.
